





- 7 The certificate may not be treated in any case for the regularization of the unauthorized construction, if any.
- 8 **The owner/ occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry. www.dfs.delhigovt.nic.in**
- 9 **Basement shall be used strictly as per building bye laws.**
